

**EXPORT REQUIREMENTS FOR THE EXPORTATION OF  
LIVE FISH FROM MALAYSIA**

A. Live Fish : Live Fish

B. Purpose : All

C. Regulations for Exportation :

**1. Basic Requirement impose by Department of Fisheries Malaysia**

**1.1** Exporters must be registered with Competetant Authority

1.1.1 Department of Fisheries Malaysia (for peninsular Malaysia and Sarawak) or

1.1.2 Department of Fisheries Sabah or

1.1.3 Department of Forestry Sarawak for CITES listed species in Sarawak

**1.2** Exporters must have a quarantine area approved by Central Competent Authority of Malaysia

**1.3** The consignment shall be accompanied by a valid export permit issued by the

1.3.1 Director General of Department of Quarantine and Inspection Services Malaysia or

1.3.2 Director of Fisheries Sabah or

1.3.3 Director of Department of Agriculture Sarawak

**1.4** Health Certificate must be issued by

1.4.1 Department of Fisheries Malaysia (for peninsular Malaysia and Sarawak) or

1.4.2 Department of Fisheries Sabah or

1.4.3 Department of Agriculture Sarawak

**1.5** Exporters for **koi fish** must obtain kois from certified farm under **Malaysian Good Aquaculture Practice (MYGAP)** certification.

**2. Description of Animal**

2.1 No. PIT (Passive Intergrated Tag) must be implanted in each Arowana

2.2 Hard coral must be tagged

**3. Animal Health Certification Requirements for Export of Live Ornamental Fish From Malaysia**

The exportation shall be accompanied by an original copy of health certificate issued by Department of Fisheries Malaysia.

**4. Quarantine Period (Depend on importing country requirement)**

The live fish have been inspected by the competent authority of the exporting country within 72 hours of export date and showed no clinical sign of diseases.

**5. Labeling of consignments**

5.1 The consignment is identified by a legible label on the exterior of every packing bag or container with the following information:

5.1.1 Name of aquaculture establishment

5.1.2 Name of exporter

1.1.3 Commodity

**6. Other Conditions**

**6.1** The consignment is accompanied with health certificates, Certificate of Origin, Export Permit, Invoice, Packing List and Billing Flight or Bill of Lading.

**6.2** The consignment is accompanied by CITES permits and certificates of Origin (for the Arowana Fish).

- 6.3** Each species and number of fish in the consignment is as listed in the Health Certificate, Invoice and packing list.
- 6.4** The commodity clearly labelled on each box

## **7. Fee**

The following fee is payable for each consignment Fee :

- i) For peninsular Malaysia = RM 15.00
- ii) For Sabah = RM5.00
